**Subject: Empanelment of Chartered Engineers for valuation purposes**

Attention of all concerned is invited to the Board's Circular No. 04/2008-Customs dated 12.02.2008 regarding "Valuation practice of second hand machinery to be adopted by all Custom Houses / Customs Commissionerates" and Public Notice no. 25/Cus/2014 dated 07.10.2014 issued by the Commissionerate of Customs (Preventive), Amritsar office wherein a panel of Chartered Engineers was constituted by this Commissionerate on the subject.

2. The validity of the constituted panel of Chartered Engineers as per approved Public Notice dated 07.10.2014 expires on 31.03.2015 or till the date of constitution of fresh panel by this office. This Commissionerate proposes to draw a fresh panel of the Chartered Engineers, who are duly affiliated to and recognized by the Institution of Chartered Engineers [India]. The panel shall be valid for a period of one year or till the next panel of Chartered Engineers is constituted, whichever is later. Preference will be given to the persons having specialization in the particular branch/field of engineering, based on the work experience.

3. The interested persons may apply by 10.04.2015 to the Commissioner of Customs, Customs Commissionerate, Ludhiana. The application, in proforma given in **Annexure-I** to this Public Notice, complete in all respects, containing the details of qualification, affiliation certificate of the Institute Chartered Engineers [India], work experience and self-declaration which shall be in **Annexure-II** to the Public Notice, shall reach the Central Registry of the Hqrs of the Commissionerate by 1730 Hours of 10.04.2015. Submission of any wrong information will result in cancellation of the membership from the panel and shall also attract penal provisions under the Customs Act, 1962. Submission of application does not bestow any right for selection. The applicant selected for the panel will be entitled to a prescribed fee for the work performed from the importer/exporter. The job assignment warrants professional expertise and counseling, and hence a high degree of integrity and fairness is expected. The certificate issued by the empanelled chartered engineer, will be in the nature of suggestive opinion and shall not be binding on the Department.

4. All the trade associations/ chamber of commerce/ members of Permanent Trade Facilitation Committee and Custom House Agents' Association are requested to publicize the contents of this Public Notice amongst their members / constituents.
